

ORA Data Exchange (DX) Training Resources Knowledge Article

Summary

The Office of Regulatory Affairs (ORA) Data Exchange (DX) Training Resources Knowledge Article focuses on the training resources (e-Learning courses and KAs) available to the public via ORAPP that provide targeted information and instructions for ORA DX systems and capabilities. e-Learning courses and KAs are developed and maintained as new data sharing capabilities are introduced and are updated as current data sharing capabilities are enhanced in the ORA DX systems.

The knowledge article topics include:

- Knowledge Articles Overview and Catalog
- e-Learning Courses Overview and Catalog
- Accessing Training Resources

Knowledge Articles Overview and Catalog

KAs are just-in-time reference documents with images, that provide instructions and guidance on ORA DX systems, capabilities, and ORA DX related initiatives.

KAs are organized in the following categories on the ORAPP Knowledge Articles page:

- ORA DX General This category contains KAs providing general information about ORA DX programs and initiatives such as ORA DX training and the Partnership for Food Protection (PFP).
- Sample Data Sharing This category contains KAs providing instructions on how to use the ORAPP Sample Collection and Sample Receipt and Analysis capabilities.

e-Learning Courses Overview and Catalog

e-Learning courses are designed to concisely deliver guidance and instructions on specific data sharing capabilities of the ORA DX systems, particularly ORAPP. Courses are non-interactive videos with a duration of 10 minutes or less.

e-Learning courses are organized in the following categories on the ORAPP e-Learning page:

- ORA DX Overview This category contains courses introducing users to the ORA DX Program, DX systems, and DX onboarding.
- **Inventory Data Sharing** This category contains e-Learning courses related to inventory data sharing such as Firm Search, Firm History, and Inventory Reconciliation.
- Inspection Data Sharing This category contains courses related to the inspections data sharing such as Non-Contracted Inspection (NCI).
- **Sample Data Sharing** This category contains e-Learning courses pertaining to the Sample Collection, Sample Receipt and Analysis domains.

Accessing Training Resources

Users can access ORA DX training resources via the <u>e-Learning</u> and <u>Knowledge Articles</u> training pages in ORAPP.

Accessing KAs

KAs can be accessed via the <u>ORAPP Knowledge Articles</u> page by any user with or without logging into ORAPP. Once on the ORAPP Knowledge Articles page, to access and view a KA:

- 1. Select the arrow next to the **category name** to display the related KAs and descriptions.
- Select the KA name to view the article. Note: Some browsers will require the file to be downloaded before viewing.




Figure 1: Accessing a KA in ORAPP

Accessing e-Learning Courses

e-Learning courses can be accessed via the <u>ORAPP e-Learning</u> page any user with or without logging into ORAPP. However, it is recommended that users with ORAPP login accounts log in prior accessing courses to avoid additional security verifications. Once on the ORAPP e-Learning page, to access and view an e-Learning course:

- 1. If you are not logged in to ORAPP, choose your **State** from the dropdown list or select **FDA** if you are an FDA user. If you are logged in to ORAPP, continue to **step 4** in this section.
- 2. Enter the name of your **Organization**.
- Select the I'm not a robot checkbox for the reCAPTCHA security verification. Note: An additional reCAPTCHA security verification window may appear. If so, complete the additional steps as indicated in the window.
- 4. Select the arrow next to the category name to display the corresponding e-Learning courses.

5. Select the **Launch** button beneath the desired course, to access it. **Note**: For security purposes, reCAPTCHA verification is required each time an e-Learning course is previewed or accessed, and the course must be launched with one minute of reCAPTCHA verification.




Figure 2: Accessing an e-Learning Course in ORAPP
